# **Legislative Report:**

Commissioner Scott Downing stated he and Chairman Philip Jay III had attended the Georgia Department of Transportation meeting. He stated two of the projects submitted by Ben Hill County were selected on the short list. The projects chosen are the bridge at Wire Grass Georgia Technical College and the four lanes on Hwy 107 and Hwy 112. He thanked everyone that was involved in the project process and the Chairman for involving him.

Chairman Philip Jay III informed every one of the public hearing for the Transportation Investment Act 2010 on September 19, 2011 beginning at 6:00 pm until 8:00 pm at the Grand Conference Center. He stated this will be an educational meeting.

Commissioner Scott Downing stated the last meeting for the Statewide Water Plan is September 12, 2011 to finalize the water plan for our area. The public is welcome to come to that meeting and make comments.

Vice-Chairman O. D. Netter reported he met with Representative Jay Roberts concerning the redistricting map. He stated Ben Hill County has to redistrict because of the population changes according to the 2010 census report. Both maps were shown to see the proposed changes.

Commissioner Scott Downing made a motion to allow David Coffey to as a question concerning redistricting. Commissioner Kathy Davis seconded the motion; which passed with Commissioner Scott Downing, Commissioner Kathy Davis, Commissioner Richard Goodman, and Vice- Chairman O.D. Netter all voting for the motion.

David Coffey ask the Commissioners what was the Ben Hill County population report was based upon. Vice-Chairman O.D. Netter answered him by saying the 2010 census report.
