

**NOTICE OF ERRORS IN BALLOT TO CONSIDER A ONE (1%) PERCENT
COUNTY SPECIAL LOCAL OPTION SALES TAX**

TO: The Qualified Voters of Ben Hill County, GA

PLEASE BE NOTIFIED THAT THERE ARE ERRORS IN THE LANGUAGE OF THE 1% COUNTY SPLOST BALLOT IN THE EASY VOTE SYSTEM. THE CORRECT WORDING OF THE BALLOT IS FOLLOWING. PLEASE REVIEW THE BALLOT PROVIDED BELOW AND USE FOR THE PURPOSE OF VOTING TO IMPOSE OR NON-IMPOSE THE 1% SPLOST.

“()	YES	Shall a special .1 percent (1%) special purpose sales and use tax be imposed in Ben Hill County, Georgia, for a period of time not to exceed twenty-four calendar quarters (six years) for the raising of an estimated total amount of \$15,000,000.00 for the purposes of funding the following capital outlay projects within Ben Hill County, Georgia, and the City of Fitzgerald, Georgia as follows: (i) \$8,250,000.00 for capital outlay projects administered by Ben Hill County, Georgia, consisting of improving, upgrading and repairing roads, streets and bridges; acquiring vehicles, materials and capital equipment for roads, streets and bridges, including signage; acquiring emergency response and law enforcement vehicles; acquiring emergency response equipment, including for E911; acquiring vehicles and equipment for solid waste; acquiring vehicles and capital equipment for the public transportation system; repairing, renovating, upgrading and improving County-owned buildings and facilities; acquiring vehicles and capital equipment for use by County departments and offices; economic development for the Development Authority of Ben Hill County, Georgia, and Fitzgerald-Ben Hill County Development Authority; acquiring equipment and fixtures for and repairing, renovating, upgrading and improving the Humane Society facility; acquiring technology equipment for and renovating, upgrading and improving the Fitzgerald-Ben Hill County Library; repairing, renovating, upgrading and improving facilities, parks and grounds of the Department of Leisure Services, including the Monitor Gym; acquiring fixtures and equipment for the Department of Leisure Services; and retiring debt of the Hospital Authority of Ben Hill County, Georgia; and (ii) \$6,750,000.00 for capital outlay projects administered by the City of Fitzgerald, Georgia, consisting of constructing, renovating, upgrading and improving facilities, parks and grounds of the Department of Leisure Services, including the Monitor Auditorium and the Jessamine Street Gymnasium; acquiring fixtures and equipment for the Department of Leisure Services; acquiring equipment and fixtures for and repairing, renovating, upgrading and improving the Humane Society facility; constructing and furnishing an addition to the Humane Society facility; acquiring and installing technology upgrades and improvements for the Fitzgerald-Ben Hill County Library; renovating, upgrading and improving the Fitzgerald-Ben Hill County Library; economic development for the Fitzgerald-Ben Hill County Development Authority; acquiring vehicles and capital equipment for public works; improving, upgrading and repairing, roads and streets; upgrading, renovating and improving property of the Downtown Development Authority of the City of Fitzgerald, Georgia, including the Grand Theatre; acquisition of equipment, real property and fixtures for the Downtown Development Authority of the City of Fitzgerald, Georgia, including sidewalk tree well planters and signage; construction of additions to buildings of the Downtown Development Authority of the City of Fitzgerald, Georgia; acquiring fire and rescue service equipment; repairing, renovating, upgrading and improving City-owned buildings and facilities, including the Depot building; public works facilities, and fire station; and constructing, equipping and furnishing a new Downtown Law Enforcement building?”
